# Parish Good Practice Guidelines



At St. Wilfrid's we believe that Safeguarding is the responsibility of the whole Church community and not just those working with children or vulnerable adults.

A copy of the Parish Safeguarding Handbook, The Parish Safeguarding Policy, the Critical Contacts List, and St. Wilfrid's Good Practice Guideline for Working with Children are all on display or available for inspection in church. This document and the Parish Safeguarding Policy are also on the church website along with links to critical contacts.

All at St. Wilfrid's who work with children are issued the **Good Practice Guideline** for Working with Children.

# Photography



We will attempt to ensure that we have parental/carer's consent for images to be taken of children, young people and or vulnerable adults involved in church activities or events before the event or activity takes place. However at a large event, such as a Nativity or crib service, it is largely impracticable to ask all parents or carers present to sign a consent form. Therefore it will be indicated before the event or activity takes place that photography or video recording will or may occur so that any parent or carer who does not wish the relevant child young person or vulnerable adult to be photographed, the subject of video recording or to be recognisable, can advise the organiser accordingly.

Wherever possible we will focus on the activity rather than the individual and will ensure that all featured in the photograph are appropriately dressed.

Photographs or video recordings of children young people or vulnerable adults taking part in church activities or events will not be used or stored in official publications or church social media/websites or displays without the written consent of the relevant parent or carer.

# Photography (Cont.)



We insist that photographs and video recordings of children young people or vulnerable adults taking part in church activities or events are not posted or shared on social media.

We ask that all concerns regarding inappropriate behaviour relating to use of images in church activities or events or material received through social media or electronic means, or intrusive photography or video recording be dealt with by saving and downloading to hard copy any relevant material and immediately showing or reporting the same to the Rector or the PVSO.
